 - Gallons of Gasoline Equivalent (GGE)
 - Greenhouse Gas (GHG)
- Helps the region to chart trends and plan for the future
 - Helps to accurately plan for future funding opportunities (grants)




Gallons of Gasoline Equivalent (GGE) of Fuel Type

14,072,969 gallons




Greenhouse Gas (GHG) Emissions of Fuel Type


2023 Greenhouse Gas Emissions Reduced by Fuel Type for Alternative Fuel Projects
